


AY2022 Participation (As of August 31, 2022)

In AY22, 432 cities participated in the Certification Program, a less than 4% decrease from AY21 (449).

Growth In Certification Program Participation





This year, we experienced a slight decrease in Level III participation. The assessment clinic attendees decreased from 25 participants in AY21 to 21 participants in AY22. TMCEC received 2 journals during AY21. Of the 2 new journals submitted, there was a 100% success rate. 3 people have passed the journal phase and achieved Level III during AY22. Of the 129 Level III clerks, 103 remain active in municipal courts and 26 have become inactive or no longer work in the court field.

The chart above shows annual participation changes within individual levels. The graph to the upper left is a snapshot of program growth trend since AY12. The graph to the lower left displays total participation by year. There has been a 1.24% increase in overall participation in AY22 from AY21.

The increase is likely a direct correlation to the easing of COVID-19 restrictions. Some courts have begun to resume in-person operations, possibly creating a need for more court support personnel and training of those personnel. TMCEC trained more than 300 new clerks in AY22. TMCEC offers a clerk certification exam on the last day of the New Clerks Seminar. Out of the 61 new clerks that tested immediately following the New Clerks Seminar, about 57% passed the Level I exam.

- The City of San Antonio has the highest number of employees participating in the Certification program with a total of 66.
- The City of Houston has the second highest number of employees participating in the Certification program with a total of 48.
- The City of Arlington has the third highest number of employees participating in the Certification program with a total of 38.
- The City of Fort Worth has the fourth highest number of employees participating in the Certification program with a total of 33.
- 16 Municipal Courts in the state have more than 1 clerks certified at Level III.
- The Cities of Austin, Belton, DeSoto, Friendswood, Georgetown, Katy, Killeen, La Porte, Missouri City, Sherman, Sugar Land, and Westlake currently employ two (2) clerks that have achieved the esteemed Level III designation of CMCC and the cities of League City, Richardson, Round Rock, and Webster currently employ three (3) clerks that have achieved the Level III designation of CMCC.
- There are a total of 33 municipal judges that have achieved clerk certification at any level.

AY 21-22 Certification Program Goals

The following includes progress of goals set for ourselves in Academic Year 2022

Expand Vocabulary Tools

Continue to expand learning tools through the addition of new legal terminology to increase the total number of vocabulary flash cards.

Update "Level III Planning Guide"—COMPLETED

This guide was previously called the "Level III Application & Requirements Packet." It will be broken down into a user friendly, updated guide to complete the Level III certification.

Update Journal Instructions—COMPLETED

Review and revise the Level III Journal Handbook to reflect a more appropriate journal & observation process. This document was created many years ago with little consideration of how the program may change. Revisions to expectations in the journal submittal process was considered during AY22.

Course of Study—COMPLETED

Develop and publish a promotional handout outlining the recommended order for completing each level and phase of the program, beginning with Level III.

Texas Map Graphic

Create map visually depicting certification participation by city or region.

Online Flash Cards—PUT ON HOLD

Find an online flash card site that allows for printing for a cost effective solution to printed flash cards.

Policy for Releasing Certification Information—COMPLETED

TCCA already has release of information policy.

Meeting with New Texas State Representative

Hold a meeting to introduce TMCEC and Education Committee Members to the new Texas State Representative.

ONGOING GOALS

TCCA L3 Mentor Program

Continue to explore and improve formalized mentoring sessions/groups for all levels of certification testing for individuals who prefer more one on one study time. The most immediate need appears to be in the Level III portion of the program, which currently has no study session. This is a TCCA project which is in ongoing development.

Update Study Guides

The Level I and Level II study guides, flash cards, learning tools and teaching materials continue to be updated to reflect changes from the latest legislative session.

City and Court Recognition

TMCEC will continue to offer further recognition for cities and courts who participate in the clerks program.

Uniform Promotional Branding

Continue to develop uniform branding of the clerk program and certification across educational seminars, publications, and media. Develop a recognizable brand associated with the program for use in promotional and recognition materials. Consider additional promotional branding, including applying the seal to more merchandise and using on certification presentation materials.

Statistical Metrics

Review and create new reports from performance data to reflect program success which can be used in promotional materials, publications and the website. Create metric definition and rules related to how statistics are shown in annual reports and other published items.

TMCEC Website-Ongoing

Continue to reimagine and update TMCEC website for the Clerk Certification website. Goals are (1) simplify accessibility of program rules, tools, and forms and (2) market the program to city management and a larger demographic. In addition, TMCEC will continue to develop new media to broaden outreach and participation.

Send quarterly notices to those not yet renewed informing them of educational opportunities.

AY22 Level III Assessment Clinic



The agenda for the Level III assessment clinic in Academic Year 2022 was geared toward addressing the concepts from the Level III required reading (14 books), such as diversity, HR management, emotional intelligence, budgeting, and court security, as well as a session to educate participants in professional journal writing.
